The Investment Fund Management Company TFI PZU S.A. ("TFI PZU S.A.") with registered office in Warsaw, acting on behalf and for the following investment funds it manages:

U.] of 2013, item 1382, as amended; “the Public Offering Act”), that following settlement of the sale of 80,741 (eighty thousand seven hundred forty and one) shares in LW BOGDANKA S.A. (“the Company”) on 28 August 2017, with the acquisition effected through ordinary transactions on the Warsaw Stock Exchange on 23 August 2017, TFI PZU Funds’ share of the total vote at the Company’s General Shareholders Meeting reduce below the 10% threshold. The details of the shareholding are shown below:
