

Assessment of the Supervisory Board of Lubelski Węgiel Bogdanka S.A. regarding the Directors' Report on Operations of the Lubelski Węgiel Bogdanka Group and the consolidated financial statements of the Lubelski Węgiel Bogdanka Group for the financial year ended 31 December 2023

(prepared in accordance with the requirement of Article 71.1.12 of the Regulation of the Minister of Finance on current and periodic information published by issuers of securities and the conditions for deeming equally important the information required by provisions of law of a country which is not a Member State of 29 March 2018)

The Supervisory Board of Lubelski Węgiel Bogdanka S.A. (Company, Issuer) hereby states and declares that it made an assessment of the following:

- the consolidated financial statements of the Lubelski Węgiel Bogdanka Group for 2023, covering:
 - a) the consolidated statement of financial position (balance sheet) prepared as at 31 December 2023, showing a balance-sheet total under assets and equity and liabilities in the amount of PLN 5,762,168,000 (five billion seven hundred sixty-two million and one hundred sixty-eight thousand Polish zlotys);
 - b) the consolidated income statement for the period from 1 January 2023 to 31 December 2023, showing net profit in the amount of PLN 687,144,000 (six hundred eighty-seven million one hundred and forty-four thousand Polish zlotys);
 - c) the consolidated statement of comprehensive income for the period from 1 January 2023 to 31 December 2023 showing net comprehensive income in the amount of PLN 684,426,000 (six hundred eighty-four million four hundred and twenty-six thousand Polish zlotys);
 - d) the consolidated statement of changes in equity for the period from 1 January 2023 to 31 December 2023, showing an increase in the equity by PLN 596,377,000 (five hundred ninety-six million and three hundred seventy-seven thousand Polish zlotys);
 - e) the consolidated statement of cash flows for the period from 1 January 2023 to 31 December 2023, showing a net increase in cash and its equivalents by PLN 259,648,000 (two hundred fifty-nine million six hundred and forty-eight thousand Polish zlotys);
 - f) notes, detailing for the adopted accounting policy, as well as additional information.
- the Directors' Report on Operations of the Lubelski Węgiel Bogdanka Group in 2023 (prepared together with the Directors' Report on Operations of the Issuer in the form of a single document); in terms of their conformity with the accounting books and documents and with the actual state of affairs.

On the basis of the analysis of:

- a) the content of the aforementioned statements submitted by the Management Board of the Company;
- b) the documents and accounting books and the information provided by the Management Board of the Company;
- c) results of additional verification activities carried out in selected financial and operational areas;
- d) with account taken of the results of meetings with the representatives of the audit firm PricewaterhouseCoopers Polska spółka z ograniczoną odpowiedzialnością Audyt sp.k., including with the key chartered auditor;
- e) the information provided by the Audit Committee on the course of the audit, its results and its significance for the reliability of the financial reporting at the Company and the role of the Committee in the process of auditing the financial statements;

and on the basis of the knowledge about the Company and the Lubelski Węgiel Bogdanka Group and a wide scope of activities undertaken in connection with the preparation and audit of the aforementioned statements, the Company's Supervisory Board believes that the Directors' Report on Operations of the Lubelski Węgiel Bogdanka Group and the consolidated financial statements for 2023 were prepared in accordance with the applicable laws and are compliant with the accounting books, documents and the actual state of affairs, they provide an accurate account of the development, achievements and situation of the issuer, and they do not cause any concerns as regards both the form and the content thereof.
